I hope this letter finds you well. My name is **Chloe**, and I am your local representative supporting Greater Manchester ICB with the implementation of FreeStyle Libre systems.

As you may be aware, Greater Manchester ICB has recently expanded access to continuous glucose monitoring (CGM) for all patients living with type 1 diabetes, and for those patients with type 2 diabetes who are managed with insulin and who meet the GMMMG criteria (scan the QR code below for details). The guidance covers the use of FreeStyle Libre in primary care without the need to refer to secondary care.
